NOTES TO APPLICATION

Entitlement to register

Only those persons who can whakapapa directly by blood lines to the hapu of Whakatohea.

Inability to complete enrolment form

To be registered as a beneficiary it is necessary that you prove your entitlement to be registered. However, if you are unable to complete all parts of your enrolment form do as much as you can and send the form in. The Trust Board will check your enrolment form, and if they are able to will complete the form for you.

Ensure you sign the declaration on page 4

Affiliation to Hapu

It is recognized many are able to whakapapa to more than one of the hapu of Whakatohea. While you must designate **one hapu** for voting purposes, you are welcome to list all the hapu you can affiliate to.

Spouse Partner

If your spouse/partner can whakapapa back to a hapu of Whakatohea then he/she will need to complete their **own** separate enrolment form. A spouse/partner who is unable to whakapapa back to a hapu can be entered on your enrolment but will not be registered as a beneficiary. However he/she will be linked to you as your spouse/partner. Your spouse/partner will also link as the other parent of the children you have listed.

Issue (Nga Tamariki)

You should list all your issue (children) on this enrolment form. Those who are 18 years or older **MUST** complete their **own** enrolment form and **sign** it themselves. Please use a separate piece of paper if you have more than eight (8) issues. Beneficiaries under the age of 18 will be registered but not for voting purposes. Once they turn eighteen (18) a Beneficiary Registration Form will be sent out for them to register for voting purposes.

Whakapapa

It is accepted your whakapapa is your personal taonga. However, it is a requirement for you to prove your entitlement to be entered onto the Whakatohea Maori Trust Board Beneficiary Register.

Change of Address & details – Amendment Form

It is important your details and address are updated if there is any change to ensure you receive voting forms and any notifications. This can be done by completing an Amendment Form.

DECLARATION

Any information received will be held by the Whakatohea Maori Trust Board and you have certain rights under the Privacy Act 1993 to see and correct personal information which the Board holds for you. The information obtained in this enrolment form may be used in any electoral process relating to the Whakatohea Maori Trust Board and in future from a Treaty of Waitangi settlement with the crown and become beneficiaries of any new post-settlement governance entity.
